

Freeware License Agreement for the Softline Software

Please read this document carefully before using your copy of this software.

This document is a legal agreement between you, the license holder (an individual or a company), and OTP.

Important

Carefully review the terms of this agreement before opening the "Softline" software. By installing or using the "Softline" software (hereinafter referred to as "The Software"), you agree to the terms of this agreement. If you do not accept all the terms of this agreement, you may not install or use the software.

1. Authorization

You may use the software and the accompanying documentation only under the conditions of this license, which means you are permitted to use the software solely in accordance with the established license agreement. The software is freeware, meaning it can be used and/or distributed freely, on as many computers as desired, with the exceptions mentioned below, provided the program remains unmodified.

The term "use" refers to saving, loading, installing, running, or displaying the software. The software is considered in use if it has been loaded or is present in the temporary or permanent memory of a computer.

2. Limitation of Liability

Under no circumstances can OTP be held liable (except as expressly stated in the publisher's declaration) to you or any other person or entity for loss of income or profit, loss or damage of data, or any other commercial or economic loss or direct, indirect, incidental, special, statutory, moral, or consequential damages concerning your use of OTP's services or reliance on such services, even if OTP was aware of the possibility of such damages or if such damages were foreseeable. 4. Termination

You may terminate the license and this license agreement at any time by destroying the software and accompanying documentation, along with all copies obtained in any manner, including those stored on backup media or otherwise. The license will be automatically revoked if you fail to comply with the aforementioned conditions.

5. Miscellaneous

This agreement represents the entire license agreement between all parties and supersedes all prior contracts and agreements binding the parties. Any additions must be made in writing between the parties. If any provision of this agreement is unenforceable for any reason, it will be modified to be considered reasonable.

6. Ownership

The software is the property of OTP. Your license does not grant you any ownership or title rights to the software and does not authorize you to sell it. You acknowledge that no part of the title or ownership rights to this software can be transferred to you. You also acknowledge that the title and all ownership rights to this software remain the exclusive property of OTP and that you cannot acquire any rights to this software except as stated in this license agreement. You agree that every copy of this software is subject to the same ownership rights mentioned in and on the software.
